

## Exclusion of Liability

The participant is aware that their participation in the Neusiedler See Radmarathon is connected with certain dangers for their physical health, which fall under the general life risk. The physical health of the participant(s) could be affected by the following dangers, among others - without this being an exhaustive list:

- Falling,
- Collision with vehicles, pedestrians, other participants or stationary objects,
- Reaching high speeds,
- Occurrence of driving and concentration errors due to own overtiredness or effort,
- Occurrence of extreme weather conditions such as rain, fog, storm, etc.; speed must therefore be adjusted to the weather conditions,
- road damages (e.g. cracks in the asphalt, potholes, etc.) or road unevenness (especially in the Hungarian territory), which represent an increased danger and are not marked separately by the organizer; neither the organizer, nor the road owner is liable for the condition of the road, the speed must be adapted to the road conditions without fail,
- riding in a crowd of bikes.

The participant is aware that their participation in this event is at his/her own risk.

In order to ensure his/her own safety and the safety of all other participants and spectators present, the participant agrees to comply with applicable laws, in particular the Road Traffic Regulations (StVO). Helmets are compulsory; escort vehicles are not allowed. The instructions of the organizer (e.g. race management, marshals, etc.) or the executive authorities must be followed without fail. Violations may lead to disqualification and the participant may be subject to further sanctions (e.g. exclusion from future competitions).

Should the participant fall behind the final vehicle ("Schlusswagen") marking the specially secured corridor at the Neusiedler See Radmarathon, he/she is aware that he/she is moving as an ordinary road user in road traffic and must also fully comply with the StVO (e.g. stop at protective paths, if necessary, take into account traffic light circuits, etc.). In addition, all participants must adapt their speed to the route, weather and traffic conditions.

***Knowing all the circumstances of the event and accepting all the risks and dangers typical of the sport, the participant waives any liability of the organizer or its agents, with the exception of***

***gross negligence or intentional damage to property, or even personal injury caused by minor negligence.***

In the event that the participant is responsible for an accident and thereby causes damage to the organizer or third parties (e.g. other participants), he/she shall bear sole responsibility for any legal consequences and shall indemnify the organizer against all third-party claims.

The organizer recommends that the participant makes sure to have an accident and liability insurance with an insurance company licensed in Austria, which specifically specializes in insurances for such sporting events.

The participant confirms that he/she is aware of the physical and technical requirements of the bike course and has trained sufficiently for the participation in this event and is physically healthy. The participant is responsible for the condition and suitability of his/her sports equipment and his/her behavior in connection with this event.

**I hereby affirm that I have read this exclusion of liability and understand its contents. I also acknowledge the conditions of participation of the organizer are known to me and accept them bindingly. This exclusion of liability must be signed personally by the participant and handed in at the start number collection. Should the participant not be able to appear in person at the start number collection, a full power of attorney including an exclusion of liability must be issued to the person collecting the start number. If this exclusion of liability is not completed in full, the participant will not be entitled to start. In this case the starting fee will not be refunded.**

**Requirements to combat foot-and-mouth disease**

**At the Pamhagen border crossing in the direction of Austrian territory, participants must dismount from their bicycles before the epidemic carpet and push them over the epidemic carpet in accordance with the ordinance of the Neusiedl am See district authority to combat foot-and-mouth disease. I hereby assure that I will adhere to the measures of the organizer and will not bypass the epidemic carpet. I assure that I will avoid any contact with animals susceptible to foot-and-mouth disease on the Hungarian section of the route.**
